## CHAPTER 5

## CONCLUSION AND SUGGESTIONS

## **5.1 Conclusion**

In this chapter, based on the results of the data analysis, the writer wants to draw a conclusion of her research of code-switching, which was found in the podcast video of Deddy Corbuzier YouTube channel entitled "Nessie Judge, Loe Tau Yang Nonton Gue Cuma 100 Orang?!". In analyzing the data containing the utterances or sentences made by the above two speakers, Poplack's theory of code-switching (1980, p. 613-615) as cited in Wibowo et al. (2017) was employed. There are three types of code-switching. They are intra-sentential switching, inter-sentential switching, and tag switching.

The findings reveal that there are eighty-six utterances categorized into intrasentential switching, thirty-nine utterances categorized as inter-sentential switching, and fourteen utterances categorized as tag switching. It can be concluded that code-switching happened in the utterance made by the two speakers, Deddy Corbuzier and Nessie Judge, in the podcast video. Further, intra-sentential switching is the most frequently used in the conversation.

Regarding the reasons for using code-switching, the writer also found the reasons which make the two speakers used code-switching in their utterances. In analyzing the data, Hoffman's theory of code-switching was applied. The writer found that

there are seven reasons for code-switching happened in the conversation between the two speakers. They are talking about a particular topic, being emphatic about something, quoting somebody else, interjection, expressing identity of the group, repetition used for clarification, and intention of clarifying the speech content of the interlocutor. It can be concluded that the most common reason which makes the two speakers use code-switching is when talking about a particular topic which occurs nineteen times by Deddy Corbuzier and twenty-nine times by Nessie Judge. When they were talking about a particular topic, sometimes they lack the exact word for the concept he or she wants to express in the language being used at the time which makes them did code-switching.

## 5.2 Suggestions

The writer realized that there are some limitations which made this research far from perfect. One of them is the fact that the writer was unable to interview the Youtubers under investigation, so the analysis only relied on the data found from the YouTube video and the notes made by the writer during the investigation.

Still, the writer hopes that this research will be useful especially for the students of FLA majoring in Linguistics. It is also expected that this research can help other researchers and readers understand better about the phenomenon of code-switching that happens in our society. The writer suggested that the next researcher can analyze not only the data taken from social media, but also interview the research participants. The writer hopes that the next researcher can add other elements in addition to types

and reasons. It would be better if the code switching research focuses on other languages, for example between Indonesian and Korean, Indonesian and Javanese, Indonesian and Chinese, Indonesian and Japanese, or Germand or other languages.
