CHAPTER 1 INTRODUCTION Background of the Study Literature is an art. A way of defining literature is to limit it to "great books," books which, whatever their subject, are "notable for literary form or expression." (Wellek & Warren, 1954, p. 10).

The form of literature or what we call literary work can be varied, such as drama, poetry, and prose. Drama is presented in the form of conversation that tells a story. Drama is different from poetry and prose, it is usually written for the purpose of being performed on stage (Lethbridge & Mildorf, 2003a, p. 90). Poetry is considered fictional. It uses specialized language which in many cases lacks a pragmatic function, and is also ambiguous (Lethbridge & Mildorf, 2003c, p. 142). The last one is prose, which is different from poetry that uses specialized language. Prose uses "ordinary language". Most literary works that are read until this day are written in prose (Lethbridge & Mildorf, 2003b, p. 42). Examples of prose are short stories, fairy tales, newspaper articles, essays
