researchers can continue the research on bullying in *My Nerd Girl* series by comparing the bullying issues with the other Indonesian films and see how different the bullying action affect the victim. Also, the writer hopes that the upcoming researchers can analyze the background portrayal of the director of My Nerd Girl 2022 series about the relation of bullying which is the main topic of the web series.
