Before the development started, the general flowchart about application development and research were designed to give mindset to developers to build the application. The flowchart as follows.




Figure 1 Flowchart of Research

III. RESULTS AND DISCUSSION Application Plot




Figure 2 Flowchart of Application Plot

The user interface will show the data and condition of the business in the system. The user interface loads every item needed by the user to serve the bureaucracy of the business.




Figure 5 Visualization of The Database Structure




Figure 6 Home Interface of Application

The user interface uses the sidebar to list all the available features. The sidebar helps the user to move from one features to another. This is needed to help the user to do a certain amount of work.




Figure 7 Product Management User Interface




Figure 9 Cashier User Interface
