The paper models the topic of OVO Fintech user comments by using LDA. The contents are fascinating. However, the authors have to fix some points to improve the quality of the paper. From the technical viewpoint, the paper has to show how to calculate the value in tables, e.g., table 4. May it be presented in a close form formula. Some words

in the table do not consist of the topic interpretation, the first column of the table. The paper has to tell readers that high or low value is better to avoid confusion. Furthermore, we need more comparison of the results with the existing work. From the presenting viewpoint, the text shown in Tables 1 and 2 is too small to see any information. We hope that it will improve the paper.

> *** Comments to Author: Please explain reason for your decision.

In the Introduction section, when describing the origin of OVO, the sequence of paragraphs should be consecutive, for example, describing the origin of OVO in paragraph 3, and then explaining Ava again in Paragraph 6. If OVO is described in the same paragraph or consecutive paragraphs, it will be easier to read.

The author uses a large number of abbreviations that do not include descriptive or regular terms. For example, LDA (Latent Dirichlet Allocation), OJK(Otoritas Jasa Keuangan), or NFCZ(Near Field Communication). If the author does not provide an explanation, it will prevent new readers from learning.

But there are some abbreviations that need to be clarified, such as CS and FGD. Because it can cause many interpretations.
