CHAPTER 5

CONCLUSION AND SUGGESTIONS

5.1 Conclusion

The purpose of this thesis is to describe Ko Mun Yeong's ASPD behavior in the Korean series *It's Okay to Not Be Okay* such as doing illegal behavior, disrespecting others, being irresponsible, impulsive, lying, and lack of regret. This thesis additionally aims to write about the characteristics of ASPD behavior of Ko Mun Yeong. The writer analysed the characteristics of ASPD behavior based on Ko Mun Yeong's dialogues and actions in some scenes.

In this Korean series, Ko Mun Yeong doing illegal behavior is one of the characteristics of ASPD. After Ko Mun Yeong did the harmful actions such as being happy to see the manager of her mother suffered from a broken neck and be transported into an ambulance. Violating others' rights and breaking society's laws are also the characteristic of Anti-social Personality Disorder mentioned by Nevid.

The second point, an aggressive and irritable behavior such as starting physical fights and attacking others are ASPD's characteristics. Here are further explanation of the aggressive and irritable behavior. Ko Mun Yeong seemed aggressive in the first episode. She fought a man, kicked and got strangled by him. When Ko Mun Yeong survived from the man, she tried to kill him. The point that Ko Mun Yeong wanted to

stab the man (Kim Seung Cheol) was failed is an example of Ko Mun Yeong being aggressive to the man.

Ko Mun Yeong was being irresponsible is also shown in a scene when she helped Moon Gang Tae's brother just because she was seeking attention from Moon Gang Tae. She attacked the man who harassed Moon Gang Tae's brother.

In the second episode, Ko Mun Yeong shows her impulsivity as said by Nevid (2005) and Cleckley (cited in Auladi, 2019). Starting from the scene when Moon Gang Tae moved to Seongjin city, Ko Mun Yeong who found out about the moving followed Moon Gang Tae. At the end of second episode, there was a monologue done by Ko Mun Yeong mentioning "red shoes" that is a referral to Moon Gang Tae, a man whom Ko Mun Yeong obsessed with. Ko Mun Yeong's actions were so impulsive that created the impression that she disregarded the reactions of the people around her.

There was also the time when Ko Mun Yeong visited the psychiatric ward where Moon Gang Tae worked. There she met Mr. Kwon who suffered from an acute manic episode. When Mr. Kwon ran into her car, Ko Mun Yeong took Mr. Kwon in and started to drive at high speed following Mr. Kown's request. Moon Gang Tae reminded her to put Mr. Kwon back in the psychiatric ward but Ko Mun Yeong ignored him and continued her driving. Here, she disrespected other people's safety in the midst of a city crowd. Ko Mun Yeong did not have any regret of her past mistakes. She did not care whether she received both bad and good comments, even though those comments could affect her future works.

From six points of the characteristics of an ASPD, all the characteristics could be found in Ko Mun Yeong. The writer can conclude that Ko Mun Yeong is an antisocial person.

5.2 Suggestion

From this study, the writer hope that the other researchers could analyze a series that is based on what usually happens in actual life. More researchers should concentrate more on ASPD behaviors because they often happen in actual life. However, future researchers must concentrate their attention on what types of behaviors to observe.
