Below are my comments on this paper:

- 1. The motivation of this study is not discussed clearly in the introduction section. The beginning of the introduction section can be shortened, as NLP, sentiment, ML, etc are not your main contributions.
- 2. Many paragraphs in the introduction section only contained one sentence.
- 3. What is your main contribution? fintech acceptance? If yes, you should discuss about fintech acceptance studies in the related work section.
- 4. It is better if the data processing stages illustrated in the form of figure in the methodology section. However, you can remove discussion and conclusion as they are not part of data processing.
- 5. I'm quite confused with the result and discussion part. What did you mean by acceptance? is it sentiment analysis or what? In addition, the discussion is lacking. You should focus on "interpreting" business insight from your results.
- 6. The implications of this study both on practices and theories are missing.
